Thefts

It has again been brought to our attention that supplies are being stolen from Horizon facilities. As New Brunswickers begin to experience the impacts of COVID-19, it is imperative that Horizon has the required stock of supplies to provide the quality and safe patient care for which we are known.

Employees who remove supplies from Horizon facilities will be disciplined, up to and including termination, reported to local law enforcement and professional associations, where applicable.

Employees who have information about the theft of supplies are encouraged to speak with their managers. Your assistance is great appreciated.

Upper River Valley Temporary Community Assessment Centre

A temporary COVID-19 Community Assessment Centre (by appointment) has been set up in the Upper River Valley at the Tobique Valley Community Health Centre, 20 Main St., Plaster Rock.

Clarification: COVID-19 and Daycare Access

As previously communicated, special arrangements have been made through Education and Early Childhood Development (EECD) to ensure that essential services employees (ALL Horizon employees) are able to access daycare services.

Horizon has confirmed with EECD that all essential services employees are encouraged to call this number and that the employment status of an essential services employee's spouse/partner will not impact access to these designated daycares.





Horizon elevated visitor restrictions to a complete ban

Due to the Covid-19 Pandemic, no visitors are allowed in Horizon facilities.

Except ONE healthy visitor in the following areas:

- Palliative Care
- Intensive Care / Critical Care / Neonatal Intensive Care
- Obstetrics and Pediatrics

Discharge (ONE healthy individual allowed to pick up discharged patients.)

For Emergency Departments:

ONE support person ONLY for patients requiring assistance. Only ONE person per pediatric patient is allowed. (Parent or caregiver only.)

For Out-patient Departments:

ONE support person ONLY for patients requiring assistance.

We reserve the right to further restrict visitation as the COVID-19 situation evolves.

Privacy

Horizon Health Network and its employees are subject to and must comply with the *Personal Health Information Privacy and Access Act* (the PHIPAA) and the regulations under that Act. As a custodian of health information, Horizon and all of its employees have an ethical and legal obligation to protect the confidentiality of personal health information and the privacy of all patients.

When talking about COVID-19, please remember Horizon's <u>Privacy</u> and <u>Confidentiality</u> policies, and the Privacy education you have received. Discussing patients with others or accessing patient information with no work-related "need to know" may result in a privacy breach.

To ensure the privacy of our patients and staff is protected, we are asking staff and patients to avoid going to our Community Assessment Centres, unless they have a legitimate health-related or work-related reason to be there.
