- Within the Enhanced Atlantic Bubble – no restrictions
- Within Canada:
  - Must have applied for NB travel registration
  - Must provide Employee Health with documentation of vaccine status
  - Agree to testing upon return to the workplace with notification to Employee Health regarding tests
  - Health care workers are responsible to book their own swabs – [COVID-19 Testing and Tracing \(gnb.ca\)](#)
- Outside of Canada:
  - Health care worker must have approval from manager
  - Must have applied for ArriveCan travel registration
  - Must have applied for N.B. travel registration
  - Must provide Employee Health with documentation of vaccine status
  - Agree to testing upon return to the workplace with notification to Employee Health regarding tests
