### **COVID-19 Bulletin**

#### **Masks and drive-thru windows**

New preventative measures from Public Health and WorkSafeNB mean face masks are now required when accessing goods through a drive-thru window — in yellow, orange and red alert levels.

This affects our staff, physicians, patients and visitors when accessing a Horizon parking booth.

Please ensure you wear a mask when interacting with a parking booth attendant (or when you go to any drive-thru). Community face masks can be worn.

Masks must be worn when physical distancing of two metres or more cannot be maintained. As most drive-thru interactions occur within this two-metre zone, masks are required for

workers and any occupants of the vehicle within two metres of the drive-thru window.

Thank you for doing your part to help slow the spread of COVID-19!

**Remember: Hand washing immediately upon entry to a Horizon facility is a requirement of all employees and physicians. All employees and physicians are required to wear a mask in order to enter a Horizon workplace.**

### [Statistics Canada survey](#)

Below is an invitation to complete a short questionnaire on the impacts of the COVID-19 pandemic on health care workers. This crowdsourcing initiative is a collaboration between Statistics Canada, Health Canada, the Public Health Agency of Canada, and the Canadian Institute for Health Information. We encourage anyone working in a health care setting to participate.

Our objective is to understand the impacts of COVID-19 on Canadian health care workers, with particular focus on

access to personal protective equipment (PPE) and infection prevention and control (IPC) measures in the workplace. The information we collect will help to inform the delivery of health care services, and to better understand what health care workers need in terms of equipment, training and support.

We want to hear from you, whether you provide direct health care services to individuals (e.g. physicians, nurses, massage therapists, dentists, dieticians), technical support to medical staff (e.g. receptionists, technicians), or other services in a health care setting (e.g. cleaning and food services staff, security).
