COVID-19 Bulletin

Orange Level reminders

With all Horizon zones in the Orange Level of the provincial recovery plan (Vitalité's Zone 4 remains in the Red Level), it's important for staff and physicians to remain familiar with how each level of recovery impacts them and their patients/clients.

In the <u>Orange Level</u>, there is a "significant risk that COVID-19 is no longer under control in the province."

At Horizon, this means:

- There will be no visitors allowed in our hospitals. Visitor guidelines and restrictions, by phase are available in both official languages here: English | French.
- All New Brunswickers are discouraged from travelling outside of their zone and are restricted from visiting a Horizon hospital outside of their zone.
 - Guidance for health care workers can be found here.

 Screening for patients and visitors should reflect the most up-to-date questions, which can be found here.

As always, all staff and physicians must:

- Self screen prior to leaving home for their shift. Screening questions are here.
- Swipe their ID badge upon entry to the facility.
- Practice frequent hand hygiene.
- Wear a mask.
- Maintain a physical distance of two metres.

Eye protection:

- All health care workers (HCWs) who provide both hands-on patient care, as well as indirect patient care (meal delivery and housekeeping) in high-risk areas (COVID-19 units, ERs, ICUs, ORs and COVID-19 Assessments Centres) must wear facial protection (face mask and eye protection) continuously, at all times in all areas of their workplace.
- The continuous use of facial protection is mandatory for all HCWs in these high-risk clinical settings.

• The continuous use of eye protection is optional for HCWs working in other clinical settings.

Reminder - Remove clothing / uniforms after a shift

To prevent transmission of COVID-19 and other infectious diseases, employees and physicians in clinical settings who wear jeans on Friday, Feb. 12 are reminded of the need for prompt removal and laundering of clothing worn at work. Clothing / uniforms should be changed at the end of a shift or immediately upon arrival at home.

When possible, it's also encouraged to leave work shoes at work. Clothing / uniforms worn at work are **not** to be worn when going to run errands or to an appointment.

Employees or physicians caring for COVID-19 patients, should proceed to a change room to remove their clothing / uniform / hospital-issued scrubs following their shift. Some may prefer to shower prior to changing into street clothes. Clothing / uniforms should be placed in a plastic or washable bag to be laundered at home.
