

#### **Self-screening reminder**

We want to remind all employees and physicians of the importance of remaining familiar with the screening questions.

#### Remember:

- Employees and physicians are required to self screen prior to leaving home for their shift.
- Once at the facility, employees and physicians must swipe their ID badge.
- Employees and physicians who leave the facility for any reason (break, meal period, to smoke, or

interfacility travel) will be required to self screen upon their return.



# **GNB** guidance on AstraZeneca

The situation regarding very rare blood clots reported post vaccination with AstraZeneca vaccines within the United Kingdom, European Union, and Scandinavian countries has been quickly evolving. The National Advisory Committee on Immunization (NACI) recommended that the AstraZeneca COVID-19 vaccine should not be used in adults under 55 years of age at this time until further analysis has been completed by Health Canada.
