**COVID-19 Infection Prevention and Control Guidance:
Interim COVID-19 Vaccination / Testing Guidelines for Designated Support Persons
Effective Oct. 18 to Nov. 19, 2021**

**Designated Support Persons (DSPs) for eligible inpatients and outpatients will be
required to be fully vaccinated by Nov.19, 2021.**

A DSP is an active partner-in-care who provides physical and emotional support to patients or clients and are different from a general or social visitor.

This deferred implementation date will provide unvaccinated DSPs an opportunity to become fully vaccinated. These measures are required for the safety of our vulnerable patients / clients, employees, and physicians.

From Monday, Oct.18 until Nov. 19, please follow the [Interim DSP COVID-19 Vaccination / Testing Guidelines](#) (also on Page 2) for Inpatient and Outpatient / Emergency Department.

These guidelines require all DSPs to be fully vaccinated and show proof of vaccination. DSPs must pass screening prior to entering a Horizon facility.

If the DSP is not fully vaccinated, the eligible patient will be asked to appoint an alternate DSP who is fully vaccinated. In circumstances where an alternate fully vaccinated DSP is not available, COVID-19 testing requirements will be implemented as outlined in the [Interim DSP COVID-19 Vaccination / Testing Guidelines](#)

Unvaccinated DSPs are encouraged to book a vaccination appointment. Information can be found on Horizon's vaccination clinic [webpage](#) or by calling 1-833-437-1424.

The [Interim DSP COVID-19 Vaccination / Testing Guidelines](#) identifies inpatient and outpatient populations eligible for a DSP, number of permitted designated DSPs, vaccination requirements, exceptions and the management of these exceptions through COVID-19 testing requirements, and a quick reference table.

**INTERIM COVID-19 VACCINATION/TESTING GUIDELINES
FOR DESIGNATED SUPPORT PERSONS (DSPs)
EFFECTIVE OCTOBER 18 TO NOVEMBER 19, 2021**

1. DSP for hospitalized patients greater than 14 days:

- DSP must be fully vaccinated
- If DSP is not fully vaccinated, exceptions can be made if no other DSP (alternate fully vaccinated DSP) is available.
 - Exceptions: DSPs who are not fully vaccinated must have a negative PCR COVID-19 test completed no more than 72hrs prior to visit, and then agree to have a test at day 5 and day 10. If visits continue to occur must have PCR COVID-19 test twice per week. Visits will be allowed to continue between testing.
 - For this population, no isolation precautions will be required, however, DSPs must self-monitor for symptoms, practice frequent hand hygiene and comply with continuous masking.

2. DSP for “Current Seven” and Other Patient Populations (End of Life/Palliative Care, Medically Assisted Death, Critical Care (includes patients in critical care state on other units (ex. Post op, Oncology, Trauma), Pediatrics/Pediatric Psychiatry, Neonatal, Women in Labour, Post Partum, and Other Patients with Cognitive /Communication Impairments (cognitive impairment leading to agitation and inability to console; communication impairment which affects care)

- DSP must be fully vaccinated
- If DSPs is not fully vaccinated, exceptions can be made if no other DSP (alternate fully vaccinated DSP) is available.
 - Exceptions: DSPs must have a negative COVID-19 test requested on day 1 (scheduled at earliest/first possible appointment). DSP will provide the healthcare team with test date and agree to have a test at day 5 and day 10. If visits continue to occur must have PCR COVID-19 test twice per week. Visits will be allowed to continue between testing.
 - For this population, no isolation precautions will be required, however, DSPs must self-monitor for symptoms, practice frequent hand hygiene and comply with continuous masking.

3. DSP from outside the extended Atlantic provinces with travel risk factors

DSP with travel risk factors will be managed in accordance with the [Infection Prevention and Control Guidance: Management of Designated Support Persons \(DSPs\) with Travel Risk Factors \(General and Compassionate Visitation\) During COVID-19 – Red Phase](#)

- Post 14 days, if visits continue, the vaccination requirement for DSPs outlined above will be followed.
- Under exceptional circumstances, such as imminent death, when the clinical scenario is such that test results will not be available within an acceptable timeframe, a one-time rapid test using the GeneXpert platform can be requested and obtained through the Emergency Department.

**Interim COVID-19 Vaccination/Testing Guidelines for Designated Support Persons (DSPs)
Effective October 18 to November 19, 2021**

4. DSPs (Support persons) for Outpatient/ Ambulatory Care/ Emergency Department

- ONE support person permitted ONLY for patients requiring physical or emotional support or assistance with decision making or communication. This person must be fully vaccinated.
- DSP must be fully vaccinated.
- If DSP is not fully vaccinated, exceptions can be made if no other DSP (alternate fully vaccinated DSP) is available.
 - Exception: pediatric patients or patients with special needs, Emergency Department visits

5. DSPs (Support persons) for Recurring Outpatient/Ambulatory Care Visits (oncology, dialysis, dressing changes, obstetrics visits (clinic visit or Ultrasound exams))

- DSP must be fully vaccinated
- If DSP is not fully vaccinated, exceptions can be made if no other DSP (alternate fully vaccinated DSP) is available.
 - Exceptions: DSPs must have a negative COVID-19 test requested on day 1 (scheduled at earliest/first possible appointment). DSP will provide the healthcare team with test date and agree to have a test at day 5 and day 10. If visits continue to occur must have PCR COVID-19 test twice per week. Visits will be allowed to continue between testing.
 - Intermittent (regularly scheduled) visits, DSP (Support person) must have a negative PCR COVID-19 test completed no more than 72hrs prior to visit.
 - For this population, no isolation precautions will be required, however, DSPs must self-monitor for symptoms, practice frequent hand hygiene and comply with continuous masking.

6. Revision to the number of DSPs permitted in Orange/Red Phase for Women in Labour

During Orange Phase:

- Women in Labour: 2 DSPs present with the patient. A Doula or a second DSP may be present if fully vaccinated and if physical space permits.

Interim COVID-19 Vaccination/Testing Guidelines for Designated Support Persons (DSPs) Effective October 18 to November 19, 2021

Overall processes in the [RHA DSP Guidelines](#) and Horizon [DSP Operational Plan](#) are to be followed. The Interim DSP Guidelines provide an overview of the number of DSPs in modified orange and red, exceptions for non-vaccinated DSPs and required IPC education for eligible inpatients and outpatients.

Guiding Principles

- DSPs must pass screening prior to entry.
- **DSPs must be fully vaccinated¹ with an approved vaccine and are at least 14 days post 2nd dose.**
- **If DSP is not fully vaccinated, the patient is to appoint an alternate DSP who is fully vaccinated.** If no alternate fully vaccinated DSP is available, **exceptions are outlined below.**
- DSPs must self-monitor for symptoms, practice frequent hand hygiene and comply with continuous masking while in hospital.
- If DSP is from outside of Atlantic provinces, follow the: [Infection Prevention and Control Guidance: Management of Designated Support Persons \(DSPs\) with Travel Risk Factors \(General and Compassionate Visitation\) During COVID-19 – Red Phase](#)
 - Under exceptional circumstances, if the clinical scenario is such that test results will not be available within an acceptable timeframe, a one-time rapid test using the GeneXpert platform can be requested through an Assessment Centre or the Emergency Department (after-hours and if death is imminent)

¹ New Brunswick accepts any COVID-19 vaccine accepted by the Government of Canada. Currently, this includes 2 doses of the vaccines manufactured by Pfizer, Moderna, AstraZeneca/COVISHIELD (Can be any combination of vaccines approved by the Government of Canada) or 1 dose of the Janssen (Johnson & Johnson) vaccine. Note: Recommendation for vaccinating those with COVID-19 vaccines not authorized by Health Canada for those staying in New Brunswick to live, work or study include 1 or 2 doses of a non-Health Canada vaccine with one dose of a mRNA vaccine (Pfizer/Moderna) administered 28 days after the last dose of the non-Health Canada vaccine.
